Old Maintenance

New Maintenance

- a) Renewal for the termite contracts from Harbor Pest have arrived. Andi will call Harbor Pest to schedule the annual termite inspection of all buildings.**

Barnes Tennis Center Alcoholic beverage license application: All residents have received a notice from the ABC that the Barnes Tennis Center has applied for a liquor license for the property located to the north of our property. Steve will investigate the application. Andi will encourage anyone that may be interested in opposing/protesting the application to fill out the protest form and send it to the ABC for review.

Revisions to Rules & Guidelines in response to a new statute AB 130. AB 130 is requiring HOA's to not to have fines over \$100, unless it proves to be destructive or dangerous to the property or persons. If the violation is resolved/repaired before the next scheduled meeting the fine cannot be applied. An attachment of the purposed revisions was supplied and will be posted on the HOA website upon final approval. The Board unanimously approved the revisions to the Rules & Guidelines.

Insurance renewals: September is the usual time when insurance renewals are expected. A total of all the policies is at a 28% increase, which would equate to about \$10 per unit. The Board has agreed to all renewals. Declarations will be posted on the HOA website when they arrive.

Financial issues
